#### SXTA is in Stage 5 of the BC Treaty Process

n October 12, 2018, SXTA chiefs from Áthelets, Leq'á:mel, Sq'ewá:lxw, Sq'ewqéyl, Ch'iyáqtel, and Yeqwyeqwí:ws sat with Canada's Minister of Crown-Indigenous Relations Carolyn Bennett and British Columbia's Minister of Indigenous Relations and Reconciliation Scott Fraser to sign a Memorandum of Understanding that moved the SXTA communities into Stage 5 of the six-stage BC Treaty Process.

"We are not signing a traditional agreement in principle, we are signing a Memorandum of Understanding that fast tracks us into the next stage of Treaty Negotiations." Chief Terry Horne of Yeqwyeqwi:ws

"The treaty will allow us to govern ourselves and to showcase and display and demonstrate that we have the capacity to move forward and look after our community members." Grand Chief Joe Hall, Ch'iyáqtel

"We are so used to saying things like full and final because that is what we had to deal with for the first 20 plus years of sitting at the table with Canada and British Columbia. It's been through the dedication and commitment and perseverance of the leadership at this table, the citizens of this nation and the negotiations team that have continued to hammer away for wanting a better life for all of our people in this country and this province." ## What does "Core Treaty" mean?

Key elements, such the constitutional relationship. selfgovernment, land ownership, and jurisdiction would be set out in a constitutionally-protected core treaty. But administrative and operational policy matters, such as program delivery and government administration, would be included in supplementary agreements, which are more easily amended than current Some topics may concluded at a later date, as part of a living document.

### Getting Youth Out on the Land . . . with Cameras

Over the summer several SXTA Youth were engaged in photography and videography projects with the aim of increasing their skills in these creative pursuits, and getting them out in S'ólh Téméxw.

Jen Archie from Sq'ewqéyl, Sky Malloway from Yeqwyeqwi:ws and Jamie Ritchie from Ch'iváqtel worked with the SXTA and Communications Outreach team and Bear Image Productions on recording treaty update events in the communities; making videos about Treaty Settlement lands (watch for those on Social Media and our website); and making their

own videos about family, home and the future.

They travelled to Leq'á:mel, Foley Lake, Mt. McGuire, Tamihi and the Coqualeezta grounds working with Go-Pros; video cameras and more to gather footage.

We hope to continue this work with our youth and are looking for others interested in reporting, podcasting, videography and photography.

"We get to do this new work of incorporating the UNDRIP into this treaty . . . It is about Section 35 of the Constitution, but it is also about the Calls to Action in Truth the Reconciliation Commission and how we build on the important work that was done 21 years ago in the Royal Commission Aboriginal Peoples." Canada's Minister of Crown -Indigenous Relations Carolyn Bennett

"[For me there are] two major points. Getting our land back. We are going to increase our land holdings by over 1000%. It is not going to solve the land question but it brings us one step closer to having some sort of idea of how to solve that land question. The other one is getting away from the Indian Act . . . a 140-year-old piece of racist legislation that limits our people. . . We are Stò:lō; we are not Indians." Chief Terry Horne
