Community Outreach Worker (Contract)

The Stó:lō Xwexwilmexw Treaty Association is seeking several Community Outreach workers to help us reach all members of our SXTA communities in advance of the vote on our Shxwelméxwelh/Constitution. Successful applicants will work in-person and on telephone and social media with members of Aitchelitz, Leq'á:mel, Skawahlook, Skowkale, Tzeachten, Yakweakwoose to provide information and gather feedback. Community Outreach workers will be part of the SXTA's Communications and Outreach Unit under the direction of the Community Engagement Coordinator. Contract will be between January 27, 2020 through March 31, 2020 with possibility of extension.

Community Champion Responsibilities:

- Attend a two-day training on January 27 and 28 and become familiar with treaty information and materials.
- Participate in door-to-door, on-line and telephone engagement work.
- Schedule meetings with and acquire and record feedback from community members.
- Assist at community engagement events.
- Work closely with Community Engagement Coordinator to ensure that SXTA has access to the most up-to-date information available for information distribution.

Requirements: Education and Experience

- Must have high school diploma.
- Must have proven computer skills.
- Must have proven written and verbal/public speaking communication skills and ability to establish rapport with people of all education and occupational backgrounds.
- Must have proven ability to work effectively as part of a team.
- Must have proven ability to maintain a healthy working relationship with staff and community representatives/members.
- Must have ability to work independently, with minimum supervision, and to maintain flexibility and adaptability in work schedule.
- A valid B.C. driver's license and unfettered access to a reliable vehicle is an asset.
- Ability to travel to the United States is an asset.
- Must have ability to maintain the confidentiality of all records, materials and communications concerning clients, staff and Stó:lō Nation required.
- Knowledge of Stó:lō Xwexwilmexw's standing in the BC Treaty Process is an asset.
- Familiarity and understanding of Stó:lō culture, traditions and history is an asset.

About the SXTA: The Stó:lō Xwexwilmexw Treaty Association is a group of six (6) Stó:lō First Nations (Aitchelitz, Leq'á:mel, Skawahlook, Skowkale, Tzeachten, Yakweakwoose) who are currently in Stage 5 of treaty negotiations.

Salary: \$20/hour; Maximum 10-15 hours a week. Travel as well as evening and weekend work may be required. Preference will be given to qualified members of one of the SXTA Treaty First Nations. Where there is no such successful applicant, all other applications will be considered. Candidate must successfully pass a required pre-employment Ministry of Public Safety and Solicitor General Check.
